4. Mandate

The Institute for Research on Learning Technologies (IRLT) has a broad mandate to engage in systematic inquiry, discussion, and information sharing related to the uses of technology in teaching and learning. More specifically, the goals of the Institute are as follows:

- A. To engage in research on issues related to the pedagogical uses of technology and to the moral, ethical, and educational implications of its use;
- B. To develop projects that make innovative uses of new technologies in teaching, learning, and related research;
- C. To maintain an active program to disseminate findings of our projects, our activities, and developments in the field to educators and other interested parties;
- D. To foster collaboration between academics, educators, and industry and government personnel on research and development problems and issues of mutual concern and interest.

5. Membership and Governance

IRLT faculty members fall into three approximate categories. Some focus on learning technologies as their primary research interest with all of their publications and grant writing centering on this topic; others have this as a secondary or joint research interest and publish less regularly in this area; while still others are mainly interested in improving their teaching through the use of technology, receive teaching/project development grants, and/or write conference papers about their teaching with technology and, more generally, support IRLT's goals. Membership is voluntary and members are not formally reviewed or classified into a particular category. 6. Annual Progress in Fulfilling Mandate

Our progress in fulfilling each of our four goals (A to D above) is summarized below.

GOAL A. Engage in Research

IRLT members were very active this year in writing peer-reviewed research publications, report writing, presenting at academic and professional conferences, and in securing research funding. The scope of our work is considerable at both the national and international levels. Listed in Appendix 2 are: 40 selected peer-reviewed articles, chapters, published conference proceedings, and books; 38 selected conference papers/talks/invited addresses/reports; over \$2.75 million in grants; and various innovative activities undertaken by members.

GOAL B. Project Development

IRLT Members Jennifer Jenson and Ron Owston each had major software development projects. Prof. Jenson's project, funded by a \$500,000 grant from the Canadian Foundation for Innovation/MRI, involved development of an accessible educational game. Also funded from the same grant Prof. Owston is developing a software tool called the Open Virtual Usability Lab (OpenVULab) designed for remote testing of website accessibility. Owston is also leading development of accessible online training modules for the Digital Rights Project International (DRPI) under a \$6000 contract from the York Institute for Health Research in collaboration with a doctoral student (Kari Kumar) and Dr. Kathryn Cook (Georgian College). Since the DRPI participants are persons with disabilities themselves, the accessibility of the web-based content for both desktop computers and handheld devices is a top priority in the design of the online materials. Additionally, the ABEL Programme, led by Janet Murphy, is developing a software tool called Personalized Learning Spaces (PerLS) for an Academic Innovation Fund project directed by Prof. Gail Mitchell (Faculty of Health).

GOAL C. Knowledge dissemination/mobilization

To fulfill our mandate of dissemination/mobilization of research knowledge, IRLT sponsors a Speaker Series each year. One of the events was co-sponsored with York's Knowledge Mobilization Unit. All events are open to the York community. The events held in 2011-12 are below:

GOAL D. Collaboration and partnerships

IRLT collaborated with Mindshare Learning Inc. to host at York the 2nd Annual Summit on Education for educators, industry, government, and educational organizations in November 2011. Over 90 participants from across North America attended.

Additionally, IRLT played a lead role in COHERE, a collaboration of 14 universities across Canada focusing on the research and practice of blended and online learning within higher education. COHERE hosted its annual conference in Guelph in October 2011 at which Ron Owston was a keynote speaker.

- Begin the creation of a digital innovation centre that focuses on student development of educational software and related technologies
